For the avoidance of doubt, for each purchase of a residential property, the Purchaser is only entitled to either the Home Purchase Price Discount or the Stamp Duty Offer(s) as set out in paragraph (4)(A2a)(iii)1. The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

Stamp Duty Offer(s)

If the Purchaser does not choose the Home Purchase Price Discount as set out in paragraph (4)(A2a)(ii)2 upon the signing of preliminary agreement for sale and purchase, the Purchaser will be offered the following Stamp Duty Offer(s):

(a) 印花稅現金回贈

Stamp Duty Cash Rebate

- (I) 凡於2014年11月30日或之前簽署臨時買賣合約，買方在按買賣合約付清樓價餘額後，可獲賣方提供印花稅現金回贈(『印花稅現金回贈』)。印花稅現金回贈的金額相等於買方就買賣合約應付的從價印花稅的70%。

First Year P-3.88% Standby Second Mortgage Loan

If the last day of the period as set out in the paragraph (4)(B2a)(iii)2(a) above is not a working day (as defined in section 2(1) of the Residential Properties (First-hand Sales) Ordinance), the said day shall fall on the next working day.

First Year P-3.88% Standby Second Mortgage Loan

買方可向賣方的指定財務機構(『指定財務機構』)申請首年 P-3.88% 備用第二按揭貸款，主要條款如下:

The Purchaser can apply to the Vendor's designated financing company ("designated financing company") for a First Year P-3.88% Standby Second Mortgage Loan. Key terms are as follows:

Interest rate of second mortgage loan for the first 12 months shall be Hong Kong Dollar Best Lending Rate quoted from time to time by The Hongkong and Shanghai Banking Corporation Limited (“Hong Kong Dollar Best Lending Rate”) minus 3.88% p.a.; thereafter at Hong Kong Dollar Best Lending Rate (subject to fluctuation). The final interest rate will be subject to approval by the designated financing company.

The maximum second mortgage loan amount shall be 20% of the net purchase price, but the total amount of first mortgage loan and second mortgage loan offered shall not exceed 80% of the net purchase price, or the balance of purchase price payable, whichever is lower. Net purchase price means the amount of the purchase price of the residential property after deducting the Stamp Duty Cash Rebate (if any) as set out in paragraph (4)(B2a)(iii)1(a) and the Early Settlement Cash Rebate (if any) as set out in paragraph (4)(B2a)(iii)2.

The maximum tenor of second mortgage loan shall be 20 years or the tenor of first mortgage loan, whichever is shorter.

The Purchaser shall provide sufficient documents to prove his/her/its repayment ability, including but not limited to providing sufficient documents to prove that the total amount of monthly instalment (being the total instalment for repayment of first mortgage loan, second mortgage loan and any other loan repayment) does not exceed 50% of the aggregate total monthly income of the Purchaser and his/her/its guarantor(s) (if any).

First mortgage loan and second mortgage loan shall be approved by the relevant mortgagees independently.

All legal documents of second mortgage shall be handled by the Vendor’s solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her/its own solicitors to act for him/her/it, and in such event, the Purchaser shall also bear his/her/its own solicitors’ costs and disbursements relating to the second mortgage.
- (i) 買方需就申請第二按揭貸款支付港幣\$5,000不可退還的申請手續費。
The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the second mortgage loan.
- (j) 買方敬請向指定財務機構查詢有關貸款用途及詳情。貸款批出與否及其條款，指定財務機構有最終決定權。不論貸款獲批與否，買方仍須按買賣合約完成住宅物業的交易及繳付住宅物業的樓價全數。

The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.

This loan is subject to other terms and conditions.

The First 3 Years Maintenance Offer is subject to other terms and conditions.

Family Purchase Offer (applicable only to the Purchaser(s) who is/are individual(s))

The Purchaser has signed a preliminary agreement for sale and purchase to purchase the residential property(ies) marked with “+” in this price list (“designated residential property”) on or before 30 November 2014 and the Purchaser has settled the full purchase price of the designated residential property in accordance with the agreement for sale and purchase;

The Purchaser (or any one of the Purchasers) or a close relative (i.e. spouse, parents, children, brothers or sisters) of the Purchaser (or a close relative of any one of the Purchasers) (whether in his/her sole name or together with other individual(s)) (“related purchaser”) has signed a preliminary agreement for sale and purchase to purchase any first hand residential property of The Wings, The Wings II, The Wings IIIA or The Wings IIIB (“related residential property”) on or before 30 November 2014 and has settled the full purchase price of the related residential property in accordance with the relevant agreement for sale and purchase; and

(III) 在完成上述第(I)及(II)段的條件(以較遲者為準)之日後的 14 日內，買方與其關聯買方須一同以書面向賣方申請至親家庭優惠，並須提供令至賣方滿意的書面文件以證明第(II)段所述之近親關係。賣方會於收到申請並確認有關資料無誤後的 45 日內將至親家庭優惠付予買方。

Within 14 days after the date of satisfaction of the requirements contained in paragraphs (I) and (II) above (whichever shall be the later), the Purchaser and the related purchaser shall jointly apply to the Vendor in writing for the Family Purchase Offer and shall provide documentary evidence to prove the close relative relationship mentioned in paragraph (II) to the Vendor's satisfaction. The Vendor will pay the Family Purchase Offer to the Purchaser within 45 days after the Vendor has received the application and duly verified the information.

The Family Purchase Offer shall be equivalent to a cash rebate of 1% of purchase price of the designated residential property. Only one Family Purchase Offer shall be offered for each designated residential property.

The Family Purchase Offer is subject to other terms and conditions.

If the Purchaser chooses to instruct his/her own solicitors to act for him/her in relation to the agreement for sale and purchase and the assignment, each of the Vendor and the Purchaser shall pay his/her own solicitors' legal fees in respect of the agreement for sale and purchase and the assignment.

Any charges that are payable by a purchaser for execution of any document in relation to the sale and purchase of a specified residential property in the development.

The Purchaser shall bear and pay a due proportion of the costs for the preparation, registration and completion of the Deed of Mutual Covenant and Management Agreement (the "DMC") and the plans attached to the DMC, all costs for preparing certified copies of title deeds and documents of the property purchased, all plan fees for plans to be annexed to the agreement for sale and purchase and the assignment of the property purchased, the costs of any statutory declaration required for application for exemption of buyer's stamp duty and/or new rates of ad valorem stamp duty, all legal and other costs and disbursements in respect of any mortgage (if any) in respect of the property purchased and all legal costs and charges of any other documents relating to the sale and purchase of the property purchased.

(4)(C2a) 至尊現金付款計劃
Supreme Cash Payment Plan

A preliminary deposit equivalent to 5% of the purchase price (“preliminary deposit”) shall be paid upon signing of the preliminary agreement for sale and purchase. The agreement for sale and purchase shall be signed by the Purchaser within 5 working days after the date of signing of the preliminary agreement for sale and purchase.

A further deposit equivalent to 5% of the purchase price shall be paid within 60 days after the date of signing of the preliminary agreement for sale and purchase.

5% of the purchase price shall be paid within 120 days after the date of signing of the preliminary agreement for sale and purchase.

85% of the purchase price (balance of purchase price) shall be paid within 180 days after the date of signing of the preliminary agreement for sale and purchase.

If the Purchaser does not choose the Home Purchase Price Discount upon the signing of preliminary agreement for sale and purchase, the Stamp Duty Offer(s) set out in paragraph (4)(C2a)(iii)1 will be offered to the Purchaser. For the avoidance of doubt, for each purchase of a residential property, the Purchaser is only entitled to either the Home Purchase Price Discount or the Stamp Duty Offer(s) as set out in paragraph (4)(C2a)(iii)1. The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

Any gift, or any financial advantage or benefit, to be made available in connection with the purchase of a specified residential property in the development

1. 印花稅優惠

Stamp Duty Offer(s)

如買方於簽署臨時買賣合約時不選擇第(4)(C2a)(ii)2段所述之置業售價折扣，則買方可獲賣方提供下述印花稅優惠：

If the Purchaser does not choose the Home Purchase Price Discount as set out in paragraph (4)(C2a)(ii)2 upon the signing of preliminary agreement for sale and purchase, the Purchaser will be offered the following Stamp Duty Offer(s):

(a) 印花稅現金回贈

Stamp Duty Cash Rebate

Where the preliminary agreement for sale and purchase is signed on or before 30 November 2014, after the Purchaser has settled the balance of the purchase price in accordance with the agreement for sale and purchase, the Purchaser shall be entitled to a Stamp Duty Cash Rebate (“Stamp Duty Cash Rebate”) offered by the Vendor which amount shall be equal to 70% of the ad valorem stamp duty and (if applicable) 70% of buyer’s stamp duty chargeable on the agreement for sale and purchase, subject to a cap of 12% of the purchase price.

The Purchaser shall apply to the Vendor in writing (accompanied with the **official receipt(s)** for payment of all stamp duty payable on the agreement for sale and purchase) for the Stamp Duty Cash Rebate at least 30 days before the date of settlement of the balance of the purchase price or the estimated material date for the development as specified in the agreement for sale and purchase (whichever is earlier). After the Vendor has received the application and duly verified the information, the Vendor will apply the Stamp Duty Cash Rebate for part payment of the balance of the purchase price directly.

- (IV) 如買方已從賣方的指定財務機構(『指定財務機構』)獲得過渡性貸款(詳情請參閱第(4)(C2a)(iii)1(b)段)，則印花稅現金回贈會首先支付予該指定財務機構用作償還過渡性貸款的未償還欠款，餘款(如有)才會用於支付部份樓價餘額。

If the Purchaser has obtained the Transitional Loan from the Vendor’s designated financing company (“designated financing company”) (please see paragraph (4)(C2a)(iii)1(b) for details), then the Stamp Duty Cash Rebate will first be paid to the designated financing company for repayment of any amount outstanding under the Transitional Loan and the balance (if any) will be applied for part payment of the balance of the purchase price.

In case of dispute, the Vendor has the right to determine the amount of the Stamp Duty Cash Rebate, and such determination shall be final and binding on the Purchaser.

Where the preliminary agreement for sale and purchase is signed on or before 30 November 2014, the Purchaser may apply for a Transitional Loan (the “Transitional Loan”) from the designated financing company.
- (II) 買方須於簽署臨時買賣合約時同時申請過渡性貸款。
The Purchaser shall make the application for the Transitional Loan at the same time as the signing of the preliminary agreement for sale and purchase.
- (III) 過渡性貸款的最高金額為就買賣合約應付的從價印花稅的 70% 及(如適用)買家印花稅的 70% 或樓價的 12%，以較低者為準。
The maximum Transitional Loan amount shall be 70% of ad valorem stamp duty and (if applicable) 70% of buyer’s stamp duty chargeable on the agreement for sale and purchase or 12% of the purchase price, whichever is lower.
- (IV) 過渡性貸款的到期日為買賣合約內訂明的付清樓價餘額的日期。
The maturity date of the Transitional Loan is the date of settlement of the balance of the purchase price in accordance with the agreement for sale and purchase.

Interest rate shall be Hong Kong Dollar Best Lending Rate quoted from time to time by The Hongkong and Shanghai Banking Corporation Limited plus 2% p.a. (subject to fluctuation). If the Purchaser shall duly repay the Transitional Loan on or before the maturity date, **interest on the Transitional Loan will be waived.**

Upon signing of the agreement for sale and purchase (unless otherwise agreed by the Vendor), the Purchaser shall deposit with the Vendor’s solicitors the amount of ad valorem stamp duty on the agreement for sale and purchase (including the fixed fee for stamping a counterpart of the agreement for sale and purchase) and (where required by the Stamp Duty Ordinance) the preliminary agreement for sale and purchase; and (if applicable) the amount of buyer’s stamp duty, for the Vendor’s solicitors to arrange for the agreement for sale and purchase and (where required by the Stamp Duty Ordinance) the preliminary agreement for sale and purchase to be stamped by the Collector of Stamp Revenue within the time limit prescribed by the Stamp Duty Ordinance.

After the Vendor has received the application and duly verified the information, the Vendor will apply the Stamp Duty Cash Rebate for part payment of the balance of the purchase price directly.

Interest rate shall be Hong Kong Dollar Best Lending Rate quoted from time to time by The Hongkong and Shanghai Banking Corporation Limited plus 2% p.a. (subject to fluctuation). If the Purchaser shall duly repay the Transitional Loan on or before the maturity date, **interest on the Transitional Loan will be waived.**
- (VI) 所有過渡性貸款的法律文件需由賣方代表律師準備及安排簽署。如買方另行自聘律師作為其代表律師處理過渡性貸款，買方須負責其代表律師有關費用及雜費。
All legal documents of the Transitional Loan shall be prepared by and arranged for signing by the Vendor’s solicitors. If the Purchaser shall instruct his/her/its own solicitors to act for him/her/it for the Transitional Loan, the Purchaser shall bear his/her/its own solicitors’ relevant costs and disbursements.
- (VII) 買方敬請向指定財務機構查詢有關貸款用途及詳情。貸款批出與否及其條款，指定財務機構有最終決定權。不論貸款獲批與否，買方仍須按買賣合約完成住宅物業的交易及繳付住宅物業的樓價全數。
The Purchaser is advised to enquire with the designated financing company about the purpose and details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.
- (VIII) 此貸款受其他條款及細則約束。
This loan is subject to other terms and conditions.

The Purchaser shall apply to the Vendor in writing for the HK\$5,000 Cash Rebate at least 30 days before the date of settlement of balance of purchase price

or the estimated material date for the development as specified in the agreement for sale and purchase (whichever is earlier). After the Vendor has received the application and duly verified the information, the Vendor will apply the HK\$5,000 Cash Rebate for part payment of the balance of the purchase price directly.

The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.

180 Bridging Loan (Applicable only to the Purchaser who is individual(s)) (“180 Bridging Loan”)

買方須於買賣合約內訂明的發展項目的預計關鍵日期前最少30日，以書面向賣方申請港幣\$10,000現金回贈，賣方會於收到申請並確認有關資料無誤後將港幣\$10,000現金回贈直接用於支付部份樓價餘額。

The Purchaser shall apply to the Vendor in writing for the HK\$10,000 Cash Rebate at least 30 days before the estimated material date for the development as specified in the agreement for sale and purchase. After the Vendor has received the application and duly verified the information, the Vendor will apply the HK\$10,000 Cash Rebate for part payment of the balance of the purchase price directly.

為免疑問，買方只可選擇使用180換樓易貸款或港幣\$10,000現金回贈。買方須為於同一份臨時買賣合約下購買的所有住宅物業選擇相同之優惠。

For the avoidance of doubt, the Purchaser can only choose either to utilize the 180 Bridging Loan or to obtain the HK\$10,000 Cash Rebate. The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

The Purchaser of the residential property marked with “#” or “##” in this price list can exercise his/her option to purchase residential car parking space(s) in accordance with time limit and manner as prescribed by the sales arrangement of the residential car parking spaces to be announced by the Vendor.

- (c) 付清樓價日期以賣方代表律師收到所有樓價款項日期為準。如上述(4)(E2a)(iii)2(a)段中訂明的期限的最後一日不是工作日(按《一手住宅物業銷售條例》第2(1)條所定義)，則該日定為下一個工作日。

The date of settlement of the purchase price shall be the date on which all the purchase price is received by the Vendor's solicitors. If the last day of the period as set out in the paragraph (4)(E2a)(iii)2(a) above is not a working day (as defined in section 2(1) of the Residential Properties (First-hand Sales) Ordinance), the said day shall fall on the next working day.

- (d) 為免疑問，使用提前付清樓價現金回贈之買方，不可申請第(4)(E2a)(iii)4段所述之180換樓易貸款。

For the avoidance of doubt, a Purchaser who enjoys the Early Settlement Cash Rebate cannot apply for the 180 Bridging Loan set out in paragraph (4)(E2a)(iii)4.

3. 首年 P-3.88% 備用第二按揭貸款

First Year P-3.88% Standby Second Mortgage Loan

買方可向賣方的指定財務機構(『指定財務機構』)申請首年 P-3.88% 備用第二按揭貸款，主要條款如下：

The Purchaser can apply to the Vendor's designated financing company ("designated financing company") for a First Year P-3.88% Standby Second Mortgage Loan. Key terms are as follows:

The final interest rate will be subject to approval by the designated financing company.

The maximum second mortgage loan amount shall be 25% of the net purchase price, but the total amount of first mortgage loan and second mortgage loan offered shall not exceed 80% of the net purchase price, or the balance of purchase price payable, whichever is lower. Net purchase price means the amount of the purchase price of the residential property after deducting the Stamp Duty Cash Rebate (if any) as set out in paragraph (4)(E2a)(iii)1(a) and the Early Settlement Cash Rebate (if any) as set out in paragraph (4)(E2a)(iii)2.

The Purchaser shall provide sufficient documents to prove his/her/its repayment ability, including but not limited to providing sufficient documents to prove that the total amount of monthly instalment (being the total instalment for repayment of first mortgage loan, second mortgage loan and any other loan repayment) does not exceed 50% of the aggregate total monthly income of the Purchaser and his/her/its guarantor(s) (if any).

First mortgage loan and second mortgage loan shall be approved by the relevant mortgagees independently.
- (h) 所有第二按揭法律文件需由賣方代表律師辦理，並由買方負責有關律師費用及雜費。買方可選擇另行自聘律師作為買方代表律師，在此情況下，買方亦須負責其代表律師有關第二按揭的律師費用及雜費。
All legal documents of second mortgage shall be handled by the Vendor's solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her/its own solicitors to act for him/her/it, and in such event, the Purchaser shall also bear his/her/its own solicitors' costs and disbursements relating to the second mortgage.

The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the second mortgage loan.
- (j) 買方敬請向指定財務機構查詢有關貸款用途及詳情。貸款批出與否及其條款，指定財務機構有最終決定權。不論貸款獲批與否，買方仍須按買賣合約完成住宅物業的交易及繳付住宅物業的樓價全數。
The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.
- (k) 為免疑問，申請第二按揭貸款之買方，不可申請第(4)(E2a)(iii)4段所述之180換樓易貸款。
For the avoidance of doubt, a Purchaser who applies for the second mortgage loan cannot apply for the 180 Bridging Loan set out in paragraph (4)(E2a)(iii)4.
- (l) 此貸款受其他條款及細則約束。
This loan is subject to other terms and conditions.
4. 180換樓易貸款(只適用於個人名義買方) (“180換樓易貸款”)
180 Bridging Loan (Applicable only to the Purchaser who is individual(s)) (“180 Bridging Loan”)

買方可向賣方的指定財務機構(『指定財務機構』)申請180換樓易貸款，主要條款如下：

The Purchaser can apply to the Vendor's designated financing company (“designated financing company”) for the 180 Bridging Loan. Key terms are as follows:

- (a) 買方必須於買賣合約內訂明的發展項目的預計關鍵日期前最少60日以書面方式向指定財務機構申請180換樓易貸款。
The Purchaser shall make a written application to the designated financing company for the 180 Bridging Loan not less than 60 days before the estimated material date for the development as specified in the agreement for sale and purchase.

Interest rate for the 180 Bridging Loan shall be one month HIBOR plus 2.25% p.a. or Hong Kong Dollar Best Lending Rate quoted from time to time by The Hongkong and Shanghai Banking Corporation Limited (“Hong Kong Dollar Best Lending Rate”) minus 2.25% p.a., whichever is lower (subject to fluctuation). Interest shall be payable monthly. One month HIBOR rate shall be quoted by the designated financing company from time to time (subject to fluctuation). The final interest rate will be subject to approval by the designated financing company.
- (c) 180換樓易貸款之貸款本金金額於貸款到期日一次性歸還。
The principal of the 180 Bridging Loan shall be repaid by one lump sum at the maturity date.
- (d) 180換樓易貸款期限為6個月。
The tenor of 180 Bridging Loan shall be 6 months.

The maximum 180 Bridging Loan amount shall be 70% of the purchase price or the balance of purchase price payable, whichever is lower.

All legal documents of 180 Bridging Loan shall be handled by the Vendor’s solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her/their own solicitors to act for him/her, and in such event, the Purchaser shall also bear his/her/their own solicitors’ costs and disbursements relating to the 180 Bridging Loan.

The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the 180 Bridging Loan.
- (i) 180換樓易貸款以該住宅物業之第一法定按揭作抵押。
The 180 Bridging Loan shall be secured by a first legal mortgage over the residential property.
- (j) 買方敬請向指定財務機構查詢有關貸款用途及詳情。貸款批出與否及其條款，指定財務機構有最終決定權。不論貸款獲批與否，買方仍須按買賣合約完成住宅物業的交易及繳付住宅物業的樓價全數。
The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.
- (k) 為免疑問，申請第(4)(E2a)(iii)2段之提前付清樓價現金回贈及/或(4)(E2a)(iii)3段之第二按揭貸款之買方，不可申請180換樓易貸款。
For the avoidance of doubt, a Purchaser who applies for the Early Settlement Cash Rebate as set out in paragraph (4)(E2a)(iii)2 and/or the Second Mortgage Loan as set out in paragraph (4)(E2a)(iii)3 cannot apply for the 180 Bridging Loan.
- (l) 此貸款受其他條款及細則約束。
This loan is subject to other terms and conditions.

如買方最終沒有使用180換樓易貸款及已按買賣合約付清樓價餘額後，可就每個住宅物業獲額外港幣\$10,000現金回贈(『港幣\$10,000現金回贈』)。
If the Purchaser does not utilize the 180 Bridging Loan and has settled the balance of the purchase price in accordance with the agreement for sale and purchase, an extra cash rebate of HK\$10,000 for each residential property (“HK\$10,000 Cash Rebate”) would be offered to the Purchaser.

買方須於買賣合約內訂明的發展項目的預計關鍵日期前最少30日，以書面向賣方申請港幣\$10,000現金回贈，賣方會於收到申請並確認有關資料無誤後將港幣\$10,000現金回贈直接用於支付部份樓價餘額。

The Purchaser shall apply to the Vendor in writing for the HK\$10,000 Cash Rebate at least 30 days before the estimated material date for the development as specified in the agreement for sale and purchase. After the Vendor has received the application and duly verified the information, the Vendor will apply the HK\$10,000 Cash Rebate for part payment of the balance of the purchase price directly.

為免疑問，買方只可選擇使用180換樓易貸款或港幣\$10,000現金回贈。買方須為於同一份臨時買賣合約下購買的所有住宅物業選擇相同之優惠。

For the avoidance of doubt, the Purchaser can only choose either to utilize the 180 Bridging Loan or to obtain the HK\$10,000 Cash Rebate. The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

Offer of Residential Car Parking Space(s)

The Purchaser of a residential property that is marked with a “##” in this price list is entitled to have an option to purchase up to a maximum of TWO residential car parking space(s).

The Purchaser of the residential property marked with “#” or “##” in this price list can exercise his/her option to purchase residential car parking space(s) in accordance with time limit and manner as prescribed by the sales arrangement of the residential car parking spaces to be announced by the Vendor.

- (c) 住戶停車位的售價及銷售安排詳情將由賣方全權及絕對酌情決定，並容後公佈。

The price and sales arrangement details of residential car parking spaces will be determined by the Vendor at its sole and absolute discretion and will be announced later.

6. 首 3 年保養優惠
First 3 Years Maintenance Offer

在不影響買方於買賣合約下之權利的前提下，凡住宅物業有欠妥之處，而該欠妥之處並非由任何人之行為或疏忽造成，買方可於發展項目的滿意紙或轉讓同意書發出日(以較早者計)起計 3 年內向賣方發出書面通知，賣方須在收到書面通知後在合理地切實可行的範圍內盡快自費作出修補。首 3 年保養優惠受其他條款及細則約束。Without affecting the Purchaser's rights under the agreement for sale and purchase, the Vendor shall at its own cost and as soon as reasonably practicable after receipt of a written notice served by the Purchaser within 3 years from the date of issuance of the certificate of compliance or consent to assign in respect of the development (whichever is earlier), rectify any defects to the residential property caused otherwise than by the act or neglect of any person. The First 3 Years Maintenance Offer is subject to other terms and conditions.
